Agenda No. 1 - Confirmation of minutes of meeting held on 03/07/2024

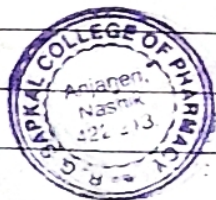
The meeting of the last meeting were read by Dr. Khanderasao R. Jadhav and also presented the action taken report (ATR) based on the decisions made during the last meeting.

Agenda No. 5 -

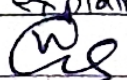
